MINUTES OF THE MEETING OF THE COUNCIL HELD ON 19 MARCH 2018 AT THE MEMORIAL HALL, NYNEHEAD

Present: Mr M Hooper, Mr G Sparks, Mr F Meadows, Dr J Butterley and Mrs A Harcombe. Also present were Mr J Frost Parish Footpaths Liaison Officer and PCSO Sharon Baker.

18/24 There were no Declarations of Interest.

18/25 The Minutes of the meeting held on 19 February 2018 were approved and signed as a correct record.

18/26 There were no Matters Arising.

18/27 Police Report.

- (i) PCSO Sharon Baker was in attendance and gave her monthly report. She stated that it had been a relatively quiet month in this beat area with a theft of fuel from a vehicle at Poole reported. She asked residents to be vigilant and report any suspicious behaviour as poaching of deer and pheasant had taken place.

18/28 Rights of Way.

- (i) Mr Joe Frost, Parish Paths Liaison Officer gave his monthly report. He reported that rights of way were as expected given the snowfall of late. He said that there seemed to be an increase in Dog waste being left on paths again especially from Tonedale along the old canal footpath.

18/29 Highways.

- (i) The Clerk had received correspondence from Somerset Highways Dept. Mr Quick (SCC Highways dept.) reported that the vegetation had been cut back at the Luckham road junction.
- (ii) The clerk reported notice of a road closure on the East Nynehead Road from the Junction with Asham Lane, north-eastwards for a distance of 300 metres on 16th April. The works are expected to last for 9 days.
