MINUTES OF THE MEETING OF THE COUNCIL HELD ON 16 APRIL 2018 AT THE MEMORIAL HALL, NYNEHEAD

- 18/35 There were no Declarations of Interest.
- 18/36 The Minutes of the meeting held on 19 March 2018 were approved and signed as a correct record.
- 18/37 There were no Matters Arising.

18/38 Defibrillator

- (i) The members agreed to accept the Quote from W.R. Cole Electrical Ltd for the installation of the Public Access Community Defibrillator for £190.00 + VAT
- (ii) After discussion the members agreed to accept the quote from Community Heartbeat Trust for the supply of a cPad semi-Automatic Defib+Mild Steel Sentry, unlocked and heated for £1650 + VAT and carriage at £25.00+VAT

18/39 Police Report.

(i) In the absence of PCSO Baker, the Clerk read out the report that she had received. The previous month had been very quiet with very few calls but theft of fuel at Poole had been reported for the second month running. PCSO Baker reminded residents to be vigilant and report anything suspicious.

18/40 Rights of Way.

- (i) Mr Joe Frost, Parish Paths Liaison Officer gave his monthly report. He stated that the footpaths were extremely muddy due to the continuous rain we had experienced.
- (ii) The Clerk reported that the new Marlow Kissing Gate on footpath WG8/4 opposite Clavengers will be installed by the end of the month.
- (iii) The Clerk was instructed to contact Wessex Water concerning the state of the Tarmac road leading to the Sewage Station in higher Nynehead.

18/41 Highways.

- (i) The Clerk had received correspondence from Somerset Highways Dept. The water under the Railway Bridge on the Nynehead Road will be cleared by a jetting machine as rodding had not worked. The repair work to the junction at Poole with the Nynehead Road was reported as not satisfactory and is being monitored by SCC Highways Dept.
- (ii) Council members instructed the Clerk to contact SCC Highways concerning several Matters including the state of the road between Grange Farm and Blockhouse Farm, collapse of the ditch at Upcott Farm and potholes on the Nynehead Road.
